RELEASE AGREEMENT:

RISKS

As a participant in one or more of 7on7U™s Events, I, the undersigned Participant acknowledge that I am aware of the possible risks, dangers and hazards associated with my participation, including the possible risk of severe or fatal injury to myself or others. I recognize that football is a vigorous contact sport and that I may suffer temporary or permanent serious physical injury including, but not limited to sprains, fractures, brain or spinal damage, paralysis or even death while playing football, participating in training drills, or attending an Event. I recognize that the types of injuries and harm mentioned in the preceding sentence can arise from a wide spectrum of causes in regard to the sport of football including, but not limited to: head injuries, broken bones, sprains, and ligament damage suffered by players impacting each other, goalposts or the ground; players getting hit by motor vehicles in parking lots or roads near fields; violent or overly rough play; playing in weather that may be too dark, too hot, too wet or too slippery; player fights; injuries caused by poor field conditions; lightning; or negligence or misconduct by coaches, parents, referees or other players.

INDEMNIFICATION

In consideration of 7on7U allowing me to voluntarily participate in the Events, I agree:

- 1) TO ASSUME AND ACCEPT ALL RISKS arising out of, associated with or related to my participating in the Events, even though such risks may have been caused by the negligence of 7on7U;
- 2) TO BE SOLELY RESPONSIBLE FOR ANY INJURY, LOSS OR DAMAGE which I might sustain participating in the Events, even though such injury, loss or damage may have been caused by the negligence of the 7on7U;
