## Committee Reports

## Bluegrass:

Frank Jurney is in Arizona but reported that 331 season tickets have already been sold which is about $\$ 5,000$. This is a great start to the year. We have up to 750 seats to sell.

## Scholarship:

Applications have been received. They will be reviewed by the committee. In years past, we have given up to $\$ 10,000$. Right now we don't have $\$ 10,000$ in the scholarship account but we have more time to move money there if we need to. Any movement of funds will be voted on by EAA members.

## Concessions:

The following parent volunteers will organize concessions: Baseball - Bobbi Ryan; Softball - Ellen Hicks; Boys Soccer Toni Novakowski; Girls Soccer - Rachelle Shendow \& Laurie Harrell; Track - Lory Chrane.

Clay Long was asked to take a look at the soccer concession stand window because it wasn't working properly. Clay was able to make the repair at no cost. Floor mats were also purchased and installed for the soccer concession stand.

We are continuing to look for a volunteer to be the concession/purchasing chair. Gary Pope will be leaving the area in about 2 weeks. His last day will be April 23, 2014. Gary has already moved most of the items from the CCHS concession stand over to the soccer concession stand. Rachelle thanked Gary for all his help over the years. Kim Braithwaite has agreed to help through the end of the year until we can find a replacement.

EAA would like to thank Erik and Julie Hoggatt for donating a new grill to the softball concession stand.
Baseball also has a new grill. Discussion was held about getting some other new grills. We have several that are not in good working order any longer. Chris McDonald is willing to donate a grill that can be used for any sport that needs one.

Discussion was also held about various options for storing grills outside vs. bring them in and out of the concession stands for each event. Carol Marshall is going to talk to Mr. Drucker about the possibility of his class constructing a building that could store the grills and gas tanks at the soccer/football concession stand. All gas tanks should be stored outside and can be locked up to the fence at the baseball and softball concession stand.

Ellen Hicks reported that some of the electric isn't working in the press box for the softball concession stand. Gary Pope said he would go by and take a look at it.

## Apparel:

Susan Catlett and Lory Chrane have moved the apparel from the CCHS concession stand back to the soccer concession stand. They also put together a tote for the softball and baseball concession stands.

Susan and Lory are also looking for someone to take over the apparel department in the next year or so. They will work with someone new to help them.
