### **Bluegrass:**

Saturday's concert was great! Baseball made \$ 777.00 in raffle sales & donations. The last 2 concerts were very good concession sales; they brought about \$ 678.00 & \$ 648.00.

The new auditorium seats 200 more than JWMS; there were about 600 people in February & March. Next year, there will only be 2 concerts (January & February).

Frank Jurney presented Debbie Hardesty, EAA President, with a check, in the amount of \$ 25,000.00 to the EAA. Many, many thanks to Frank & Cindi Jurney!
