Debbie Hardesty, EAA President, called the meeting to order at 6 pm .
The minutes from the April $7^{\text {th }}, 2014$, meetings were available for review. Motion was made by Ellen Hicks to accept the minutes as provided. Stacy Sefton seconded the motion. All members voted in favor of accepting the minutes as submitted.

Karen Russell, EAA Treasurer, presented the account balance as $\$ 51,022.70$ (\$ 41,269.97 sports; $\$ 4,661.32$ scholarships; $\$ 5,091.42$ capital improvements). Tammi Rhoads made a motion to accept the Treasurer's report. Carol Marshall seconded the motion. All members voted to accept the Treasurer's report.

## Committee Reports:

## Bluegrass:

Frank stated that this coming Bluegrass Concert Series is one of the best line-ups ever. All expenses have now been covered thru ticket sales, any future sales are all profit.

## Scholarship:

Stacy Sefton presented the scholarship application information. There were 18 applications submitted; only 1 was not eligible. The EAA will award 17 scholarships.

The following 3 options regarding transfer amounts to the scholarship fund were also presented: Option 1 - transfer $\$ 3,438.68=\$ 8,100$; Option 2 - transfer $\$ 3,538.68=\$ 8,200$; Option 3 - transfer $\$ 3,938.68=\$ 8,600$.

The motion was made by Frank Jurney to transfer $\$ 3,938.68$ from the Sports account to give the Scholarship account \$ 8,600.00 for scholarship distribution. The motion was seconded by Tammi Rhoads. All voted in favor.

## Concessions:

Ellen Hicks will coordinate with Clay Long regarding quoting \& installing the metal roll-up window to be installed in the softball concession stand. The motion was made by Stacy Sefton to spend up to $\$ 1,000$ for supplies to fix the softball concession stand window. The motion was seconded by Laurie Harrell. All voted in favor.

Gary Pope has now moved and Kim Braithwaite has returned to help us finish out the school year stocking the concession stands. Kim stated that Gary left us with stocked shelves, we are looking good. Thank you Kim for stepping in again ... and thank you Gary for not leaving our cabinets bare!

Jenny Fernandez will be opening the concession stand for graduation on June $5^{\text {th }} @ 4: 00 \mathrm{pm}$. She will be selling drinks and candy. Lisa Dale has volunteered to help Jenny.

We are tabling the discussion on purchasing a shed until next month.
Laurie Harrell expressed concern about people borrowing utensils \& equipment from the main concession building. If there are needs in the softball or baseball concession stands, please let us know \& we will purchase the items so that all the concession stands will be well equipped. However, in the meantime, if you do borrow any items from the main concession, PLEASE return those items promptly.

## Apparel:

Susan Catlett reported that sales continue \& are going well. Susan \& Lory are still looking for volunteers to help them next year on the apparel committee.

## Old Business:

Sports Physical day is Saturday, May 10 th, from 8:00-11:00 am. Lisa Manahan has done a terrific job lining up all the doctors, nurses \& PA's. Thank you Lisa! We welcome any volunteers interested in coming to help out on Saturday.

## New Business:

Coach Jon VanSice has asked the EAA to help with purchasing uniforms for the wrestling team. Coach requested 15 singlet's, in the amount of \$ 1,159.15. Coach Vansice responded that the team would love to get 22 uniforms, in the amount of $\$ 1,648.90$, plus shipping, totaling approximately $\$ 1,700.00$. This is an increase of about $\$ 500.00$. The motion has been amended \& approved as stated above.
