## Treasurer's Report/Voting on FCVA expenditures - Maureen Burgess

Expenditures:
Boys basketball purchased equipment for drills, coaches vest and NH sports subscription.
Nordic had $\$ 175$ donation towards their overnight trip and they also used a portion of their funds for that trip.
Wrestling - $\$ 1500$ revenue however $\$ 1000$ of that is from 5 other schools who sent in entry fees for a tournament that was cancelled. The coach made the decision to deposit those funds into the wrestling acct. S Kolk and M Burgess will inform M Swasey.
FCVA - $\$ 150$ for 2 seperate reports (State and Federal) for the past 2 fiscal years. M. Burgess is reviewing and amending all past financial records.
FCVA board voted via email to approve a 50/50 split, Hoops for Hope/FCVA for the concession revenue during the Hoops for Hope tournament.

1) Girls Lacrosse - \$ to offset the cost for gym memberships, Board approved and AD approved
2) Girls Basketball - \$820 for jackets, Board approved and AD approved

Net Income for the fundraiser: \$6920.00-\$346.00 (5\% FCVA) = \$6574 for team distribution ( $\$ 9.50 /$ ticket sold). The above amount does not include donations made to individual teams. Conflict of Interest statement was decided upon and brought to the Board for consideration however FCVA already has a Conflict of Interest statement. K. The Conflict of Interest statement form will need to be reviewed and signed annually.
M. Burgess will research the cost of a fireproof, 2 drawer filing cabinet for FCVA documents. She will present her findings at the February meeting.

## New Business

FCVA purchase ideas:

Window film update - Gibb West is asking for testimonials from staff, students and coaches that there is a problem and that the crow's nest view is a distraction. M Swasey is in favor of the window film. S Kolk has asked for clarification regarding installation and who would be responsible. K. Heck will speak with Band and Chorus for feedback and will share it with Gibb West.

Additional ideas for FCVA purchases include but are not limited to the following:

1) Game Fan buses for Away games
2) Bleachers for the lower fields
3) Convection oven for concessions
4) Upgrade sound systems for both Outdoor stadium and indoor basketball court
5) Kinesio tape for the Athletic trainer
6) An outdoor concession building with bathrooms and a first Aid station (Capital project)

Items to be purchased this year will be discussed at the February meeting.

Meeting on $1 / 8 / 18$ with M. Swasey and FCVA Board members; M Burgess, K Heck and C Hixson.
$M$ Swasey is asking for team input on the top 5 items to be included in the teams' budget. There was a discussion of ideas for use of team funds to benefit all athletes within the FCVA program as well as spending a $\%$ of funds raised per each sport.
M Swasey would like to know FCVA's' plans for possible Capital Projects in the future. He has also asked that the Board review and give feedback on the Hollis-Brookline Booster Website that he forwarded to the Board.
