IRS/Taxes Update- *Note the below information was sent via email to FCVA board members to be included in the February minutes* -
Maureen Burgess spoke with the IRS re past years taxes:
2014-2015 year (year 1) - FCVA did not file
2015-2016 (year 2) was filed
2016-2017 (year 3) extension was granted with due date of $6 / 15 / 18$. This extension was also granted for all State reporting as well.
Maureen was told that year 1 was waived because FCVA filed year 2. Maureen does not have to file an amended return for year 2 taxes even though we made a tad over $\$ 50,000$ threshold after she made a few changes to accounting for income. (Under \$50,000 means filing a postcard - simple and done online) Priority 1 for Maureen at this time is State filing for year 2.
