Treasurer's Report/Voting on FCVA expenditures - Maureen Burgess

Girl's Lacrosse - \$1602 for apparel, coaches apparel and jamboree participation

Nordic - \$100 at Windblown, Sr banquet

Spirit - \$171 for their Banquet

Track - \$566 for equipment

Volleyball - \$55 to update their Record Board

A sample of the proposed budgets was presented (FCVAs Operational budget). This sample of the budget format is in preparation for the budgets that will be set for all of the sports that participate within the FCVA umbrella.

Coaches will be asked to give a WISH list at the end of the season for possible expenditures for the coming season.

The goal of the budget: FCVA vote and approval of the AD before the season starts (this will decrease the number of email votes currently taken by the FCVA board as the expenditure requests come in during the season).
