    - i) March Month End (report below)
      - (1) \$61,432.05 ending checking account balance, \$17,433.66 in savings, \$7,669.69 in charitable gaming, total balance \$86,535.40
      - (2) Charitable gaming account can only be used to pay out for equipment purchases, so we will be spending down this account.
      - (3) Change in charitable gaming is for purchase of tents for boys lacrosse (to be used by boys lacrosse/girls lacrosse/boys soccer/girls soccer)
    - ii) Team Accounts

- (1) Currently have 3 teams using Team Accounts (boys golf, boys baseball, girls softball).
- (2) Booster has provided \$500 minimum balance to avoid fees, this is not for team spending.
- (3) The team accounts are theirs and will not be reported on as general business.

- 2) Scholarship Update
  - a) Currently have 14 senior scholarship submissions, 3 underclassmen scholarship submissions students have until the end of this meeting to submit (must have digital submission).

  - b) Senior scholarships will be awarded at Senior Honors Night (May 14, 2024)
    - i) Awards will be paid directly to the school (not the student), in the event of a zero balance, the school will refund the student.
  - c) Underclassmen scholarships will be awarded at our May meeting (May 8, 2024)

      - (5) Congratulations, Kim Van Dam-Jones! She will be the incoming Secretary starting tomorrow. Kim Vaughn will pass along information.
  - c) This year's goal as a board was to increase membership (and we did win!). Next year's goal will be to button things up...review rules, reward active members, update bylaws.
- 4) Volunteer Incentives / Ideas
  - a) This year, we tried assigning teams to handle Concessions. Football season went great, basketball season was not as good, spring season even worse. Concessions had to close on Girl's Basketball Senior Night due to lack of volunteers. We need to make changes going into next year, and want to have an open discussion for ideas. Items shared will be noted and the board will get together and meet at some

point after the May 8th meeting to discuss ideas shared and make plans for the year ahead.

- i) Raffle Drawing at end of season (get a ticket for each time of volunteering)
- ii) Dereck Raymond will email Mike with information on how Adams does it, indicating that it seems to work well.
- iii) Prize (Yeti Cooler, as example) for the person who volunteers the most.
- iv) Rochester pays teams (portion of concessions for filling spots)(1) Mentioned we did this for playoffs (split profits with teams that covered)
- v) Requiring x hours or pay a set amount by senior year, or you don't play.
  - Mentioned this would have to be a school requirement or implemented by coaches, and potential issues (like it's harder to enforce when the person is your start player)
- vi) JV covers Varsity, Varsity covers JV
- vii) Target Freshman/Junior High parents
  - (1) We don't utilize Freshman families or communicate well with them
- viii) At time of membership, send out a confirmation link and ask people to sign up for a game good idea

      - (1) Idea of carting coolers and supplies back and forth does not sound fun or sustainable
      - (2) Trailer to sell out of (would need truck to tow)
      - (3) Contract food trucks for a percentage of profits
  - b) Is there a team parent assigned for each sport? Can it be required?

- i) Typically it takes someone stepping up, it's not always someone assigned by the coach
- ii) Push to require one would have to go through school (Mr. Bertich)(1) Some coaches recognize the benefits/need, others don't
