SCHOOL STATEMENT OF FAITH

The following is the foundation of beliefs on which Hickory Christian Academy is based. They are also the key elements of Christianity that will be unapologetically taught in various ways through all grade levels. The substance of these statements is that which will be considered primary doctrine in Hickory Christian Academy. Secondary or divisive doctrines and issues will not be presented as primary doctrine. When these types of doctrine or issues arise they will be referred back to God's Word as the final authority under the guidance of the family.

- 1. We believe the Bible to be the only inerrant, authoritative Word of God. (II Timothy 3:16-17, II Peter1:21)
- 2. We believe that there is one God, eternally existent in three Persons: Father, Son, and Holy Spirit. He is omnipotent, omniscient, and omnipresent. We believe He has all authority and power and whatever He purposes will come to pass. (John 10:30, 37, 38; Genesis 1:1)
- 3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory. (*Isaiah 7:14; Matthew 1:23: Luke 1:35; Hebrew 4:15; Hebrews 7:25; John 2:11; Hebrews 9:12; Ephesians 1:7; Colossians 1:14; John 11:25; Acts 1:11; Revelation 19:11-16)*
- 4. We believe that for the salvation of lost and sinful men, regeneration by the Holy Spirit is absolutely necessary. (Romans 3:19, John 3:16-19; John 5:24; Ephesians 2:8-10; Titus 3:5-6)
- 5. We believe that "all have sinned and fall short of the glory of God" and are, therefore, separated from God and deserve death. (Romans 3:23; Romans 6:23)
- 6. We believe that Jesus Christ died for our sins so that our fellowship with God could be restored, and we could live righteously. (I Peter 2:24)
- 7. We believe in the cleansing from sin through confession and repentance to God through the Lord Jesus Christ. (*I John 1:9; Acts 3:19*)
- 8. We believe that there is salvation in no other Person than Jesus Christ, and that "if you confess with your mouth Jesus as Lord and believe in your heart that God raised Him from the dead, you shall be saved." (Acts 4:12; Romans 10:9; John 14:6)
- 9. We believe that salvation is by grace through faith alone; it is the free gift of God. (Ephesians 2:8-9; Romans 6:23)
- 10. We believe that faith without works is dead. (James 2:17, 26)
- 11. We believe in the present ministry of the Holy Spirit, by whose indwelling the Christian is enabled to live a Godly life. (*Ephesians 4:30; I Corinthians 3:16; I Corinthians 6:19-20*)
- 12. We believe all Christians are commissioned to go and make disciples and to teach them to obey God's commands. (Matthew 28:19-20)
- 13. We believe in the resurrection of both the saved and the lost, they that are saved to the resurrection of life and they that are lost to the resurrection of damnation. (John 5:28-29)
- 14. We believe Jesus Christ unites all believers through the indwelling power of the Holy Spirit. (*Galatians 3:26-28; I Corinthians 12:12-13*)
- 15. We believe that the Church is being prepared as the eternal bride of Christ, and is reflected on earth through marriage between one man and one woman. (Rev. 19:6-8; Eph. 5:22-33; Hebrews 13:4)
- 16. We believe that God immutably creates each person to reflect His image as specifically male or female. (Gen. 1:27; Gen. 5:2; Matt. 19:4)
