### COVID GUIDELINES FOR INDOOR EXTRA CURRICULAR STAGE 3 REBOUND IDAHO

Gatherings as defined in this Section do not include "educational activities". The term "educational activities" means activities involving students taught by an educator in a school or equivalent setting; OR

Extra-curricular activities, including athletics, practices, matches, performances and games may continue, including attendance of the participants necessary for the competition to occur, including but not limited to players, instructors, coaches, and officials. Attendance by non-participants, including spectators, remains subject to the requirements specified in this Order, including but not limited to those identified in Sections I (a), (b), and 3.

- Section 1      Gatherings. As defined by the CDC "gathering" means "a planned or spontaneous event, indoors or outdoors, with a small number of people participating or a large number of people in attendance such as a community event or gathering, concert, festival, conference, parade, wedding, or sporting event."
- a.            Indoor Gatherings. Indoor gatherings of more than 50 people, both public and private, are prohibited. Indoor gatherings of 50 or fewer people must adhere to the Physical Distancing and Sanitation Requirements in Section 3 of this Order.

In light of Governor Little's recent public health order, moving Idaho to a Stage 3, school districts across the state are making some adjustments to athletic events. PCSD 25 has made the following adjustments:

#### High School

- ALL banquets; athletes and coaches only in attendance, effective immediately.
- All visiting teams show up ready to play, may use locker rooms for team meetings (half time and pre-game). No changing into uniforms in locker rooms.
- All venues **50 spectators** maximum per event (sit in designated areas marked out, one side of gym JV spectators, other side designated for Varsity spectators) **25 – home spectators** (2 per basketball roster athlete) **25 – visiting spectators** (2 per basketball roster athlete). Spectators will not be allowed into the gym until 10 min before their athlete's game time. Gyms will be cleared of spectators between games. Coaches spouse will be allowed into games (no other family members)
  - Spectators are required to wear masks for the duration of the event.
  - Individuals not residing within the same household shall maintain at least six-foot physical distancing from other individuals whenever possible.
  - Clear after each event and clean and then allow 50 spectators for next event.

- Possible Venmo to purchase tickets (name of athlete tied to purchase) schools may use wrist bands or season passes.
  - All other spectators will be able to watch using NFHSnetwork.com
- 
- **Cheer and/or Dance** sign up for half time performance with AD (cheer and dance will come a few min before half time, dressed and ready to perform then will be asked to leave). Cheer or dance spectators will be able to watch with NFHSnetwork.com
  - **Wrestling** - due to high number of participating athletes, spectators will be asked to watch using NFHSnetwork.com (guidelines from state coming soon).

### Middle School

- ALL Banquets athletes only in attendance, effective immediately.
- Middle School events spectators will be limited to 2 passes per rostered program (basketball, cheer and wrestling) for **HOME EVENTS. No visiting spectators allowed.**
- Middle School cheer are required to wear masks at all times (unless conditioning at practice).
