Officer's reports

- Treasurer's Report (Jeremy Reeve)– accounts have been moved and are all with SunTrust now, the account has been reconciled; team accounts are being updated
- Secretary's Report (Dawn Harvey) – minutes for June and July meeting have been posted, website has been updated
- Member at Large Report (Theresa Brown) – board approved:
  - 3 new grills for concessions;
  - contributing \$15,000 to the PHS Activities Department to help with start-up costs;
  - a total of a \$25,000 budget for Spirit Wear, \$10,000 of which will go toward their first purchase

Committee Reports

- Spirit Wear (Traci Marin) – orders are in; up and running; had some technology issues that have been resolved; will be selling at the Freshman/New Student Open House and home Varsity games; will try to sell during some lunches but not sure will be able to
- Concessions (Gayle Jenkins) –
  - 2 of 3 grills are here and ready to be put together, will be doing so at concessions this Sunday at 2pm
  - All Pepsi and US Foods products are in, the ice cooler is full and working, concessions stand is ready to go – need volunteers
  - Volleyball and Field Hockey want to work their own events, will be training inside on Tuesday for volleyball
- Membership/Sponsorship (Jeff Loague) – we have 20+ members to date; business sponsorships are ready -forms are available online; advertising is also available -there are different levels, forms are available online

#### Old Business

- Steve has measurements of smaller safe, but forgot them, will send them to Brad
- 2,421 Pioneer Cards have been distributed to coaches, additional 250 were just received; going well to date – great feedback about cards, there is one vendor, Famous Daves, that has closed

#### New Business

- New team/club funding requests –
  - Request from orchestra to fund one student at \$850 to participate in All National Orchestra, decision was tabled due to the need for more information
  - Request from Football for the hardware/software for a sideline video system for \$1,500 to be used for instructional purposes and to increase team success, other sports would be able to use it if the rules of the sport allow it; Jeff made a motion to purchase the system, motion was seconded by Dawn, motion passed 6-0
- BJ's Wholesale Club has agreed to do a membership fundraiser again for a three week sales time frame (9/11 – 9/29) - \$35 regular membership, \$75

rewards membership for both new and renewals plus 3 free months; forms will be returned to front office

- Discussion regarding changes to funding request guidelines, Dawn will draft changes discussed and email to the board
- We will be selling memberships at the New Student Open House on August 23<sup>rd</sup> and Back to School Night on September 7<sup>th</sup>
- Next meeting will be September 13<sup>th</sup> at 6:30pm in the Drama Room
