Total assets were \$159,305.99.

Current Activities Budget is \$83,043.18.

Operating general fund balance is \$76,262.81.

Net fundraising profit is \$102,632.46.

- Jeremy reported about the fraud that occurred in our SunTrust account. A person had altered a check made out to US Foods and instead put their individual name on the check. The account has been closed. A new account has been established as of April 30th. All the bank cards have been moved. Most of the money has been moved.
