New Business

- New team/club funding requests
 - Track and Field they are partnering with Battlefield HS to purchase a Link System Camera and Computer system. This system allows them to run meets more efficiently.  - Boys Basketball requested \$1300 for the Hudl Assist software. This is without a discount. If we can have the girls basketball also agree to purchase the system, we could see a decrease in cost.
