- The Board unanimously passed the request for \$35.25 for all-state band registrations
- The weight room request was deferred until the sponsor could be present to present the request for equipment
- The Board unanimously passed funding the band \$10,000 of the \$20,872.17 requested for instruments and instrument equipment.
