

# PLAYER INJURY RELEASE

## RELEASE AGREEMENT:

"Company Name" and its officers, directors, employees, agents, licensees, subsidiaries, consultants, independent contractors and affiliates are not responsible for any injury, loss or damage of any kind sustained by any person while participating in the "Company Name" passing tournaments, linemen competitions, camps or other clinics, together (Events), including injury, loss or damage which might be caused by negligence.

## RISKS

As a participant in one or more of "Company Name" Events, I, the undersigned Participant acknowledge that I am aware of the possible risks, dangers and hazards associated with my participation, including the possible risk of severe or fatal injury to myself or others. I recognize that football is a vigorous contact sport and that I may suffer temporary or permanent serious physical injury including, but not limited to sprains, fractures, brain or spinal damage, paralysis or even death while playing football, participating in training drills, or attending an Event. I recognize that the types of injuries and harm mentioned in the preceding sentence can arise from a wide spectrum of causes in regard to the sport of football including, but not limited to: head injuries, broken bones, sprains, and ligament damage suffered by players impacting each other, goalposts or the ground; players getting hit by motor vehicles in parking lots or roads near fields; violent or overly rough play; playing in weather that may be too dark, too hot, too wet or too slippery; player fights; injuries caused by poor field conditions; lightning; or negligence or misconduct by coaches, parents, referees or other players.

## INDEMNIFICATION

In consideration of "Company Name" allowing me to voluntarily participate in the Events, I agree:

- 1) TO ASSUME AND ACCEPT ALL RISKS arising out of, associated with or related to my participating in the Events, even though such risks may have been caused by the negligence of "Company Name";
- 2) TO BE SOLELY RESPONSIBLE FOR ANY INJURY, LOSS OR DAMAGE which I might sustain participating in the Events, even though such injury, loss or damage may have been caused by the negligence of the "Company Name";
- 3) TO HOLD HARMLESS AND INDEMNIFY "Company Name" from any and all liability for any damage to the property of, or personal injury to, any third party, resulting from my participation in the Events;
- 4) TO HOLD HARMLESS AND INDEMNIFY "Company Name", and each of its respective directors, officers, agents, contractors, employees, volunteers, members and representatives from any and all claims, demands, actions and costs which might arise out of my participating in the Events, even though such claims, demands, actions and costs may have been caused by the negligence of "Company Name".
